Adopting Children from Hong Kong by Local Families

Services for applicants:

- Assessmentfor prospective families
- Adoption training and counselling
- Attend and participate in the matching panel organized by Adoption Unit of the Social
 Welfare Department for discussion about the matching.

Who would need adoption?

Children under the guardianship of the Social Welfare Department in Hong Kong,
 whose parents are not able to take care of them.

Who can likely adopt?

- At least 25 years old;
- Having been residing in Hong Kong for at least 1 year;
- Couples married for at least three years, or single applicants who can provide the child a stable home with adequate resources to parent an adopted child;
- Having completed 6-year primary school or above;
- Have no criminal record;
- Have good physical & mental health

Application and assessment procedures:

1. Expressing interest

Interested persons may email us at ia@isshk.org or call us at (852) 2834-6863 to discuss about their adoption plan.

2. Attending briefing session

All applicants have to attend the briefing sessions organized by the Adoption Unit, Social Welfare Department.

3. Submitting application

If the applicants meet the requirements after initial screening, we will send them an application package. Applicants have to submit us the application form, required documents and registration fee.

4. Undergoing assessment

We will assign a social worker to conduct the home study assessment, during which the social worker will interview the applicants and conduct home visit. Local referees and persons living in the same household with the applicants will also be interviewed. The applicants need to complete the adoption training before home approval can be granted.

5. Home approval

After passing the assessment, the applicants are approved as Prospective Adoptive Parents (PAPs). They will be placed into the home pool for matching.

6. Matching

A matching panel meeting is scheduled by the Social Welfare Department. A child waiting for adoption will be matched to a family in the home pool which can best meet the child's needs.

7. Considering proposal

If the family is selected for a child, our social worker will discuss with the family to see if they would accept the matching proposal. Information and medical reports of the child will be provided to the family for their consideration.

8. Meeting your child

If the matching proposal is accepted, the family will meet the child, together with the social worker of the Adoption Unit, Social Welfare Department.

9. Moving in

The adoptive family can bring the child home and start to live together when the latter is ready.

10. Finalizing adoption

After a child is placed in the family, post-placement supervision will be undertaken by the social worker of the Adoption Unit, Social Welfare Department for a period of not less than 6 months, before an adoption order is granted.
